

Information about the special airport Oberpfaffenhofen

Permitted flights at Oberpfaffenhofen

Permitted users include those involved in customer service, development, production, maintenance, outfitting, modification, and sales of aircraft or aerospace components, as well as designated business flights.

Permitted in designated business flights are departures and landings according to IFR (Instrument Flight Rules) operations with aircraft having a maximum take-off mass (MTOM) of at least 2.000 kg and up to 25.000 kg. In addition, the following aircraft models up to MTOM 45.500 kg are allowed: Falcon 7X, Global XRS (including Global 5000, Global 6000, and Global Express), Gulfstream G550 (including models G350, G450, G500, G650, GIII, GIV, GV).

Helicopters with an MTOM up to 5.000 kg operating according to IFR or VFR (Visual Flight Rules) are also permitted.

Designated business flights also include:

- Air taxi operations
- Corporate aviation
- Other non-commercial flights

A maximum of 9.725 flight movements per year is allowed within designated business flight operations.

Scheduled Airline Operations

Scheduled airline operations in form of time-scheduled charter flights are not permitted.

Hours of Operation (Times CET)

Monday to Friday	07:00 – 21:00	Subject to noise protection regulations
Saturday	08:00 – 21:00	Subject to noise protection regulations
Sunday and Public Holidays	09:00 – 21:00	Subject to noise protection and quota limits

Flight Operations on Sundays and Holidays

- Generally, no flight operations are allowed on Sundays and Public Holidays
- However, with prior approval from the airport operator, a maximum of 200 flight movements per year may be conducted on these days (in compliance with noise protection requirements).
- Requests for flights on Sundays or holidays must be submitted by 18:00 CET on the preceding business day.
- Helicopter operations in designated business flight operation are not permitted on Sundays and Public Holidays.



Noise protection

Noise protection Monday to Saturday, 07:00 – 19:00 CET

- Jet and turbine-powered aircraft must at least comply to the noise protection requirements of ICAO Annex 16, Chapter 3.
- Propeller-driven aircraft must at least comply to the enhanced noise protection requirements of § 4, paragraphs 2 and 3 of the "Landeplatz-Lärmschutz-Verordnung" dated 5. January 1999.
- Helicopters must comply to the noise protection requirements of "LSL Kapitel VIII."

Noise protection Sundays, Holidays and Mo. – Sa. after 19:00 CET

- Jet and turbine-powered aircraft must at least comply to the noise protection requirements of ICAO Annex 16, Chapter 4.
- Propeller-driven aircraft must at least comply to the enhanced noise protection requirements of § 4, paragraphs 2 and 3 of the "Landeplatz-Lärmschutz-Verordnung" dated 5. January 1999.
- Helicopters must comply to the noise protection requirements of "LSL Kapitel VIII.".

PPR (Prior Permission Required)

Departures and landings require prior permission (PPR) from the airport operator. For registration and further information, please visit https://my.airport.software/EDMO.

Passport Control / Customs

Border controls for all flights to or from non-Schengen countries must be registered at least 5 hours before the planned landing or departure via https://my.airport.software/EDMO.

The following information is required for border controls:

- Registration
- Departure and arrival aerodrome
- Estimated time of departure and arrival
- Lastname, first name, date of birth, place of birth and ID number of passenger
- Lastname, first name, date of birth, place of birth and ID number of crew member

Customs

PPR requests for all flights entering or leaving the EU customs union must be submitted to the airport operator as soon as possible, preferably 24 hours in advance, but at least 5 hours before the planned flight. (Exceptions are subject to agreement with the airport operator and customs authorities.)

The following information is required for customs clearance:

- Registration
- Departure and arrival aerodrome
- Estimated time of departure and arrival
- Lastname, first name, date of birth, place of birth and ID number of passenger
- Lastname, first name, date of birth, place of birth and ID number of crew member
